
1. On page 1, we have updated the principal office address of the Company in accordance with its Amended Articles of Incorporation.

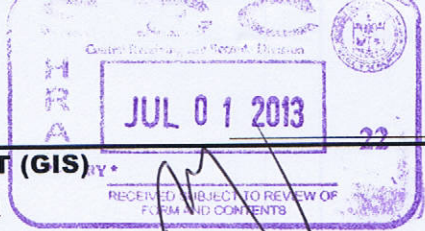
