Item 9. Other Events

Further to our disclosure dated 16 February 2016, on the results of the tender offer conducted by VLL to all the remaining shareholders of Starmalls, Inc. ("STR"), we disclose that, based on the updated report of the Tender Offer Agent, Maybank ATR Kim Eng Securities, Inc., a total of 6,972,627 STR Shares were tendered (the "Tendered Shares"), 3,526,727 STR Shares will be settled under the Cash Payment Option and 3,445,900 STR Shares will be settled under the Reinvestment Option. An estimated 2,119,227 VLL Shares will be transferred to tendering shareholders under the Reinvestment Option. The Tendered Shares represent 0.083% of the total outstanding common shares of STR.

Following the transfer of the Tendered Shares to VLL, the public float of STR will be approximately 11.664%.
